Well Status: Suspension of the Cameron C-74 Well (ACW-2018-004-SOG-C-74-WID1939)

The Office of the Regulator of Oil and Gas Operations has received the Well Operations Report and Well Termination Record for the Cameron C-74 well. The report has been reviewed and satisfies the requirements of section 89(1) of the *Oil and Gas Drilling and Production Regulations* (OGDPR).

Our records have been updated identifying the status of the well as Suspended and in compliance with the Downhole Well Suspension Requirements (Section 5B) of the *Well Suspension and Abandonment Guidelines and Interpretation Notes* (Guidelines). All operators must maintain and monitor suspended wells according to all requirements of the Guidelines and the ODGPR.

As indicated in section 1 of the Guidelines, a re-suspended well must be brought back into production or abandoned within six years. Therefore, the Cameron C-74 well must be brought back into production or abandoned by March 31, 2025.
