**Well Status: Suspension of the Cameron H-58 Well (WID 1975) OA-1237-001**

The Office of the Regulator of Oil and Gas Operations has received the Well Operations Report, Well Termination Record and Change of Well Status form for the Cameron H-58 well slickline suspension. The report has been reviewed and satisfies the requirements of section 89(1) of the *Oil and Gas Drilling and Production Regulations (OGDPR)*.

Our records have been updated identifying the status of the well as Suspended and in compliance with the Downhole Well Suspension Requirements (Section 5B) of the *Well Suspension and Abandonment Guidelines and Interpretation Notes (Guidelines)*. All operators must maintain and monitor suspended wells according to all requirements of the Guidelines and the ODGPR.

As indicated in section 1 of the Guidelines, a re-suspended well must be brought back into production or abandoned within six years. Therefore, the Cameron H-58 well must be brought back into production or abandoned by March 31, 2025.
