

Regional Geology: Enclosed with this Report is a Regional Map of the Slave Point Structure and Keg River Facies. No seismic or surface geology has been carried out by Amerada Minerals Corporation, and drilling results in the surrounding Area have been disappointing. However, due to the lack of wells in the immediate area of the Permits, this land has not been fully evaluated.


