DRILLING AUTHORITIES ISSUED FOR NORTHWEST TERRITORIES

YELLOWKNIFE — During the week of February 2, 1986, the Canada Oil and Gas Lands Administration issued five authorities to drill a well for four new exploratory wells and one new delineation well in the Northwest Territories.

The four exploratory wells are as follows:

- Esso PCI Home et al Hansen G-07, located at 69°36'20.2" N and 134°1'11.7" W, which is expected to be spudded on February 8, 1986, has a total proposed depth of 3265 m KB.
- NSM et al Arrowhead D-50, located at 60°29'15" N and 122°54'13" W, which was expected to be spudded on February 10, 1986, has a total proposed depth of 2900 m KB.
- NSM et al Blueberry Creek K-53, located at 64°42'34" N and 126°25'42.8" W, which was expected to be spudded on February 10, 1986, has a total proposed depth of 2800 m KB.
- PCI Canterra Bele O-35, located at 66°34'58.1357" N and 126°21'32.1083" W, which was expected to be spudded on February 10, 1986, has a total proposed depth of 1386 m KB.

The one delineation well is Esso PCI Home et al TukTuk D-11, located at 69°20'11.6" N and 133°04'40.5" W, which was expected to be spudded on February 7, 1986, and has a total proposed depth of 1800 m KB.

YELLOWKNIFE – During the week of February 2, 1986, the Canada Oil and Gas Lands Administration issued five authorities to drill a well for four new exploratory wells and one new delineation well in the Northwest Territories.

- Esso PCI Home et al Hansen G-07, located at $69^{\circ}36'20.2''$ N and $134^{\circ}1'11.7''$ W, which is expected to be spudded on February 8, 1986, has a total proposed depth of 3265 m KB.
- NSM et al Arrowhead D-50, located at $60^{\circ}29'15''$ N and $122^{\circ}54'13''$ W, which was expected to be spudded on February 10, 1986, has a total proposed depth of 2900 m KB.
- NSM et al Blueberry Creek K-53, located at $64^{\circ}42'34''$ N and $126^{\circ}25'42.8''$ W, which was expected to be spudded on February 10, 1986, has a total proposed depth of 2800 m KB.
- PCI Canterra Bele O-35, located at $66^{\circ}34'58.1357''$ N and $126^{\circ}21'32.1083''$ W, which was expected to be spudded on February 10, 1986, has a total proposed depth of 1386 m KB.

The one delineation well is Esso PCI Home et al TukTuk D-11, located at $69^{\circ}20'11.6''$ N and $133^{\circ}04'40.5''$ W, which was expected to be spudded on February 7, 1986, and has a total proposed depth of 1800 m KB.
