2003 Summer Site Inspection Report		
Wellsite and campsite clean-up was conducted late August 2003. Rig moved out July 2003.		
During wellsight clean-up phase site drainage was installed, pad area graded for drainage, barricade installed on wellhead.		
Access turn-out, on Chevron road, partly restored, small turning radius turn-out constructed, into wellsight. Fill backslopes were graded. Fertilizer was applied to pad perimeter areas. Campsite area clean-up completed except for one kitchen sump. Drilling fluid disposal completed by MBC. Other kitchen sump clean-up completed.		
Site graded and stripings spread. Works remaining, winter 2003/04 include, pump-off one remaining kitchen sump and backfill and haul stockpiled hogfuel (sawdust) to K-35 for invert drilling phase.		
Future Monitoring/Works Required		

Fall 2004 Inspection Report

Sites were inspected and photo graphed 19 Oct/2004. The following was observed.

On well site west boundary some blow down has occurred. Blow down is not on or leaning into well site or Paramount pipeline ROW. Recent blow down is evident in many areas near the well site. One small saw dust pile and water well on site. No erosion or water ponding observed. Portable bridge in place on pipeline and fill ramps in good condition.

At campsite one camp sump is open with fluid, freeboard is 1.5meters and fencing is down. No settlement visible on remote sump and other camp sump areas. Strippings and debris roll-back not completed. Camp sump to be sampled early November 2004. Pump-off and camp site area clean-up to be conducted .

Fall 2005 Inspection Report

Sites were inspected Sept 16 /2005. One remaining campsite (km 10.5 Paramount Rd) was pumped-off and backfilled. Campsite area clean-up completed, spreading of stripings and seeding. . No settlement on remote sump area observed. Natural re-vegetation established. At P-16 well site grating was installed on cellar and junk pipe and planking was removed.

No erosion evident on any sites. Natural re-vegetation catch is slow on well site.
