Job Objective: Move in Drilling Rig and Drill I-78 Well. Complete three observation water wells.

Present

Operation: Wait on Rig Move trucks due to Government NWT road closure. Moving drilling equipment from Staging to Location. Water Well Rig completed drilling and logging Water Well #3. Set and cement 406mm conductor pipe.

Daily Operations Details

Held a safety meeting with MGM, Northridge/MYB, Black Opel, Aecom, Alken Basin, PTI, Akita, and Frontier medic personnel.

Access Road and I-78 Location

Hauled remainder of drilling support equipment from staging area to location. Cancor augered and set 17.65m (GL) of 406.4mm conductor pipe. Augered a cellar and installed a 1.82m x 1.22m cellar cribbing. Schlumberger cemented conductor with 6 Tonne of Arctic set cement. Cement and water returns were placed in a 15m³ waste tank. Schlumberger released. Black Opel continued to rig in sewer system on wellsite units.

Rig Move

Mullen bed truck transported remaining drilling support equipment from the staging area to the location. Took delivery of two 15m³ waste fluid tanks and one lift of 12"x 12" timbers for casing racks.

screens and 4.5" tubing and completed Water Well #003 Attempted to develop GW001 and GW002 using submersible pump - encountered problems with water freezing in the tubing, tried manually bailing the wells; however this is inefficient and ice began building up inside the casing quickly risking the bailer being caught in the well. GW003 was unable to be pumped due to ice build up in the casing, steam was placed inside the casing to try to solve this, but did not work.

Access Road and I-78 Location

Black Opel thawed and continued to rig in sewer system on wellsite units (80% completed). Offloaded the remainder of casing on location. Seven highboys ready for backhaul. Whiponit electrician provided the required parts to get electricity to the Akita Rig Managers Wellsite - heat is on. Akita Rig Crews layed enviro-liner on drilling pad and spotted substructure matting. Assembled and spotted pony sub. Borealis completed communications set up at location. Build the 250m wildlife windrow breaks on the access road. Moved about 50% of mud product from staging area to location.

Ice Road

Cleared blown snow from ice road with grader. Feathered back snow windrows with BR180 Snowcat. Responded to a request from Fred Lamb Government NWT Department of Transportation to assist with traffic control on both sides of the Tulita Ice Crossing.

Rig Move

Regulator Contact:	AANDC Inspector Joe Carnogursky inspected the staging area, the tank farm, WWTP and WTP. Expressed an interest in inspecting the location but stated he would come back on Jan 22 due to the high volume of traffic on the road. Submitted Weekly AANDC Report.					
Safety:	Incident: Wellsite Fire At 02:30 hr Trevor said Guy Custair (Akita Rig Manager who was sleeping in the unit) was wakened by a smoke detector. Guy observed flames coming through the heat vent in the far end shower room. Guy used a fire extinguisher and the fire was extinguished. Further investigation showed that the sewage lift station and heat traced sewage line behind the geo wellsite had caught on fire allowing flame to follow the sewage discharge line into the shower portion of the trailer. The wellsite supervisor contacted the Field Superintendent who mobilized the Black Opel Tech, a bed truck operator, a water truck operator, and both their company's supervisors immediately. The bed truck positioned and pulled the geo wellsite out into the east center of the location. The wall was inspected for heat and it appeared to be cooled down. The water was drained from the unit. Larry Blunden investigated today, took pictures, and is preparing an incident report and hazard analysis.

Moved loads that arrived during the night and that were held at the staging area up the access road to the location. Spotted the substructure, spotted the pony sub for the water and the water tank. Positioned the doghouse for the pickers to install tomorrow. Spotted the mud tanks and installed the shakers. Started assembly of the prefabs on the mud tanks. Installed the motors in the pump houses. **Unable to attach derrick to skid due to picker truck breakdown.** Replacement picker truck on location- will attach tomorrow.

Ice Road

Graded the outgoing lane on the ice road.

Rig Move

Mullen trucks delivered the balance of the rig loads to location. Remaining loads to arrive include 2 ea pipe tubs in Ft Simpson. One pipe tub loaded and driving north from Ft Simpson. From Baker Hughes Nisku - all the downhole tools loaded on Mullen Units 7116 and 01820. Mullen Unit 1820- Cougar Tools and Weatherford double gate. Two tool baskets and 4 tubulars from Baker in Clairmont. There is one more load at Baker-Nisku to load out tomorrow. SWANBURG - One wellsite unit from Ft St John.

One load of loose pipe at Formula Powell in High Level. One load at Hallmark Nisku - Might not be ready until Wednesday.

Daily Operations Details

Held a safety meeting with MGM, Akita, Black Opel, PTI, Peak and Frontier medic personnel.

Access Road and I-78 Location

Moved remaining rig loads to location. Spotted remainder of rig equipment. Spotted centrifuges, centrifuge generator, shale bin, premix tank and two 400 Bbl tanks for stripped drilling fluid. Spotted the boilers, the light plant and two Akita containers. Heated and fired up the boiler. Hauled three loads of water to the water tank. Fired up the light plant. Fuel truck from Norman Wells removed the remaining 15,000 L of fuel from the 60,000 L enviro-tank and transferred it to the rig. The 60,000 L enviro-tank was transported and spotted at the rig for reserve fuel. Spotted, leveled, powered up, and got the heat operational in the Geologist Wellsite Unit. Rig is 95% spotted and 20% rigged up. Break tour tonight with 2 only Akita personnel. Personnel arriving today were Warriar Top Drive, Matrix Tech, Two Continental Mud Loggers, Pason Tech, and Three Akita.

Ice Road

No work on the ice road. Excellent shape.

Rig Move

Took delivery of the remaining pipe tubs, the Geology Wellsite Unit, and the Cameron landing joints and wellhead equipment. Loaded and transported I- Matts and four 8' x 40' rig matts from staging area tank farm to the location. Released one bed truck and backhauled one 15,000 L enviro-fuel tank to Hodgson in Norman Wells. Released the picker truck.
