- 1) Conduct annual ground water sampling and pull pump and cables.
- 2) Install wellhead. Disinfect zone with bleach.
- 3) Rig in Service Rig and run tubing to PBTD.
- 4) Balance cement from PBTD to 3 to 5 meters from surface.
- 5) Tag cement top and pressure test.
- 6) Cut and cap 1m below surface. Rig out equipment.
