**Well Status: Abandonment of the
Loon Creek O-06 Well (ACW-2015-005-CPC-O-06-WID2080)**

On October 29, 2019, ConocoPhillips Canada (CPC) provided the Office of the Regulator of Oil and Gas Operations (OROGO) with the results of its gas migration (GM) testing for the Loon Creek O-06 well, conducted on September 10, 2019.

OROGO has reviewed the 2019 testing results and the results of previous GM testing conducted by CPC on August 15-16, 2016, September 5-7, 2017 and September 23, 2018. OROGO is satisfied that the GM testing results indicate that the Loon Creek O-06 well has degassed to a background state.

OROGO has received the Well Operations Report, Well Termination Record and Change of Well Status form for the Loon Creek O-06 well. This information has been reviewed and satisfies the requirements of section 89(1) of the *Oil and Gas Drilling and Production Regulations*.

Our records have been updated identifying the status of the Loon Creek O-06 well as abandoned and in compliance with the Well Abandonment Requirements (Section 6) of the *Well Suspension and Abandonment Guidelines and Interpretation Notes*.
