**Well Status: Suspension of the Cameron J-62 Well (ACW-2019-004-SOG-J-62-WID 1158)**

The Office of the Regulator of Oil and Gas Operations (OROGO) has received the Well Operations Report, the Well Termination Record and the Change of Well Status request for the Cameron J-62 well. The report has been reviewed and satisfies the requirements of section 89 of the *Oil and Gas Drilling and Production Regulations* (OGDPR).

Our records have been updated identifying the status of the well as Suspended and in compliance with the Downhole Well Suspension Requirements (Section 5B) of the *Well Suspension and Abandonment Guidelines* and Interpretation Notes (Guidelines). All operators must maintain and monitor suspended wells according to all requirements of the Guidelines and the OGDPR.

As indicated in section 1 of the Guidelines, a re-suspended well must be brought back into production or abandoned within six years. Therefore, the Cameron J-62 well must be brought back into production or abandoned by March 31, 2026.
